- a. Senate Execute Committee's Response to Concerns on the DeltaGE Report Vote in the Senate
  - M. Wagner read a response from the SEC Chair on this issue. The overall message is that
    nothing is set in stone, this is merely a vision, and we want to get input from as many
    constituencies as possible.
- b. Report from the first Delta2GE Meeting
  - Decision to get as much feedback as possible.
  - One member felt that because of the makeup of the new committee, it woke the rest of the
    university to how CLAS uses Gen Eds and their requirements and the extra resources that
    they may be getting because of it. CLAS is "pumping up enrollments" by having more Gen Ed
    requirements, rest of the university did not realize the extent to which this is happening.
    This is how TA lines are protected.

- In first committee were told to keep resource discussions at arms lengths, but now in phase two we need to bring resources back into the conversation.
- One member said there was concern about a group that CLAS was creating to feed information and strategies to the representatives on Delta2GE. There is a lot at stake for CLAS.
- Manuela has a document of 40+ pages currently that she is compiling on feedback.
