M. Morrell motioned to approve the minutes. K. Tonry seconded. The minutes were approved with one abstention.

4. Chair's Report

A. Delta2GE Update

- One issue is the persistent push or desire to add more themes of inquiry. The group has heard
 two proposals, one on race and diversity, and one on a dialog requirement. There is also still
 some discontent that the international multiculturalism requirement has been taken out. There
 are many themes the group wants to include, but they are limited by their goal of not adding
 additional credits to the requirements.
- The Life-Transformative Education (LTE) committee is also working on some similar ideas.
- There was discussion of the distinctions between civility and dialog and what the proposal is
 actually suggesting. There was some concern about giving a platform to ideas that we truly
 consider unacceptable, e.g. fascism. It was also clarified that the pitch to add a "civility"
 requirement was suggested several years ago. The newest suggestion is to add "dialog," but
 there is still concern here.
- One member asked if Delta2GE can make an announcement about what the timeline for implementation is because faculty and staff do not know where things stand and departments

are unsure if they should move forward on Gen Ed initiatives. M. Wagner will speak with Veronica Makowski from SEC regarding an announcement, and a statement will be drafted. The bottom line is that implementation of new requirements is still years away, so departments should proceed as normal.

The Info Lit subcommittee is struggling with understanding their purpose. It seems as though
there is no Info Lit requirement, so there is no way to enforce Info Lit guidelines. The committee
is questioning what the purpose of putting the work in is if Info Lit will basically be relegated to a
website.

B. Life-Transformative Education Task Force (LTE)

 This task force was convened at the behest of the President Katsouleas. There was debate about whether this meant the initiatives of the task force would be more or less likely to receive adequate funding.

C. Senate Executive Committee

- M. Wagner and Tom Long originally thought that they needed to have a report to the Budget Committee by February, but that deadline has been extended and they will present a report to the Senate by April.
- One member asked whether this is an actual proposal or a progress report. At this point it is a progress report.
- The task force will likely need to have town hall meetings to get feedback on a larger scale, but
 they currently do not have anything concrete enough to vote on. The committees are working on
 refinements and fixing issues or impediments. Once they complete that work, then they can look
 at resources.
- One member expressed concern about whether there will actually be adequate resources to
 enact this initiative. They reiterated a concern from the last meeting, that we have gotten two
 dichotomous directives from the President: double our research and transform life in the
 classroom. Faculty cannot reasonably do both.

5. Subcommittee Dockets

A. CA1 Docket

- M. Gomes presented the CA1 report.
- The subcommittee was waiting for a new syllabus for the ECON course. They received it yesterday, but they have not had a chance to review it yet, so that class is still pending.
- The subcommittee is having "existential problems" about the MUSI 1115. The course fulfills CA1
 criteria on a fundamental level, but there is a question about whether or not the required
 audition is an impediment to approving the course as a Gen Ed since it potentially violates the
 principle of accessibility.
- One member asked whether functionally students from any major could take the course, or if it
 was really meant for MUSI students. What is the course's purpose? If MUSI is looking for high
 quality musicians for a jazz ensemble, then the course probably cannot be Gen Ed.
- S. Majumdar motioned to table consideration of MUSI 1115 pending further research and consultation with the department. B. Day seconded. The motion to table was approved unanimously.

- ARE 1150 is still pending. The subcommittee is checking to see if consultation with ECON occurred.
- The subcommittee did not feel as though the HDFS course adequately addressed CA2 criteria, so they are declining it.
- One subcommittee co-chair felt that there was a general misunderstanding about the type of ethical issues to which the CA2 criteria refer.

The CA2 Report was approved as submitted unanimously (declined for HDFS 2142; pending ARE 1150).

 - K. Tonry presented the W Report on behalf of L. Blansett and B. Ginsberg, who could not attend.
 - The report gave notice of discussions with Peter Diplock of CETL about the possibility of building a training program for graduate students in teaching W courses. GEOC members expressed concern about paying for this grad student time and requiring this commitment. One member noted that they would need to talk to Kent Holsinger and the Grad Student Union about this idea.
 - On a related noted, M. Wagner conveyed that the Registrar's Office wanted to know about enforcing the 19 student enrollment cap in W courses. Whose purview is it to hold this line? One member noted that this has become an issue in Stamford. Another member noted that we should also look at the 50% enrollment restriction for majors since this is also being abused.
 - There was further discussion of which parts of the proposed training would in fact be union issues.

6. Q Assessment (Report)

 K. Chen gave a brief overview of the report by Eric Loken, and then explained the Q subcommittee's discussion of the report.

- It was noted that W courses have low enrollment caps because of the level of focused attention that is needed per student. There is almost a similar need in Q courses, partially due to "math anxiety."
- There was a suggestion to GEOC to support an increase in Q Center resources to help combat some of these issues. It was noted that the Q center does not offer as many resources as faculty seem to think it does.
- The report suggested that it is time to revise the Q criteria in light of the rise of big data and artificial intelligence.
- PHYS, CHEM, MATH, STAT courses are the purview of the Q Center. At the regional campuses the need for resources is even more dire.
- One member felt that talking to a counselor was more appropriate to deal with math anxiety than sending students to the Q Center. The Academic Achievement Center is also a potential resource.
- GEOC will reserve time next meeting to discuss the report further.
